OFFICE MEMORANDUM

Subject: Modified Assured Career Progression Scheme for the Central Government Civilian Employees vide DoPT O.M No. 35034/3/2008-Estt. (D) dated 19/5/2009 circulated by CSIR vide letter No. 5-(63)/2009-PD dated 1/7/2009

In accordance with the MACP Scheme, to financial up-gradation under the MACP Scheme in the entire Government service career of an employee shall be counted against regular promotions availed from the Pay scale in which an employee was appointed as direct recruitment. This shall mean that three financial up-gradation under the MACP Scheme shall be available only if no regular promotion during prescribed periods (10, 20, 30 years) have been availed by an employee. If an employee has already got one regular promotion, he shall qualify for the second financial up-gradation only on completion of 10 years of regular service under the MACP scheme. In case three prior promotions on regular basis have already been received by an employee, no benefit under the MACP Scheme shall accrue to him/her.

Accordingly, the tentative eligibility list of Assistants (Gen, F&A, S&P) Gr. I, II, III, Senior and Jr Stenos. who have completed 10, 20, 30 or 10 years or more service in his/her present grade, upto 30/6/2011 has been prepared, for consideration under the MACP Scheme which envisages merely placement in the higher grade pay/grant of financial benefits only. However, this scheme is not promotional scheme hence, therefore no seniority shall be considered for this purpose except completion of number of prescribed years in the present grade:-
